### KEY QUALIFICATIONS

I hold a PhD (Math-Mathematical Statistics) and a Masters Degree in Statistics majoring in econometrics. My interests are mainly related to applying Statistical Methods to analyse diverse social, economic, and health situations. My particular areas of interest in Statistical methods are Mathematical Statistics, Multivariate Statistics, Linear Models, Econometric Modeling, Sampling and Survey Design, Social Statistics, Official Statistics, Biostatistics, inferential Statistics and Probability Theory. During my work as a National Programme Officer at the Population Secretariat I was in charge of Monitoring and Evaluation of various HIV/AIDS interventions. While working as a Statistician at the Medical Research Council (MRC) I was in charge of collecting, managing & analysis of data generated from clinical trials of HIV/AIDS drugs for Scientific Publications. I was one of the pioneers in the application of the Sentinel Community Surveillance (SCS) methodology in Uganda. The SCS method combines quantitative research techniques with qualitative rapid assessment procedures to gather evidence while involving clients in the process of evidence-based planning. Baseline and Monitoring Surveys as well as the use of Handheld Devices (Pocket PCs) for data collection (Mobile Surveys).
